- **Distribution:** M. FLAMAND will discuss the findings from the non-life distribution questionnaire sent to insurers in 2024 and will recommend best practices.
- **Regulatory topics:** M. FLAMAND and M. HARDMAN will provide insights from their respective perspectives of supervisory authority and practitioner on significant current regulatory topics including Value for Money, the complaints questionnaire sent by CAA, the Digital Operational Resilience Act (“DORA”), the AML credit & surety exemption and the Corporate Sustainability Reporting Directive (“CSRD”).

Language: The session will be held in English.
